### COVID-19 Vaccination Exemption Accommodation Form

As of October 1, 2021, the resident companies of the Denver Performing Arts Complex: Colorado Ballet, Colorado Symphony, Denver Center for the Performing Arts, and Opera Colorado will require that all patrons who attend public performances in Boettcher Concert Hall, Buell Theatre, Ellie Caulkins Opera House, Garner Galleria Theatre, Jones Theatre, Kilstrom Theatre, Singleton Theatre, and Wolf Theatre be fully vaccinated against COVID-19. Any patron who has either (1) a medical condition or disability that prevents taking the COVID-19 vaccine or (2) a sincerely held religious belief, practice, or observance that prevents the person from taking the vaccine will be permitted, as a reasonable accommodation, and required to provide proof of a negative COVID-19 PCR test taken within 72 hours of the performance start time, or a negative COVID-19 antigen test taken within six hours of the performance start time in lieu of proof of vaccination. Anyone who requests such accommodation (for themselves or their minor child or ward) will be required to (1) complete and sign the form below, (2) bring the completed and signed form to the event, and (3) bring proof of a negative COVID-19 PCR test taken within 72 hours of the performance start time, or a negative COVID-19 antigen test taken within six hours of the performance start time that was administered by an official testing center to the performance. Home testing kit results will not be accepted for entry. Masks are required regardless of accommodation for all patrons ages 2 and older.
